John Hansen, a licensed engineer in the states of New Jersey and Pennsylvania introduced himself and discussed the last time he appeared before the board. The meeting was adjourned until there was more information. A well driller was hired to locate the well. It was verified that the well is exactly 54.8 ft from the proposed disposal bed. There is no record of the casing. Mr. Hansen provided 8 weeks of ground water monitoring data and a potable water testing report to the board. Mr. Hansen is requesting a waiver for the 100 ft distance requirement. The engineer is also seeking approval for the pump system in the new design because the invert of the disposal system does not allow for a gravity system.

Chair Colburn asked if there were any additional questions or discussion; there was no response.

2. Block 73/Lot 8 – Fine Engineering – 1060 Route 523

Time heard 7:12 p.m.

Doug Fine, a licensed engineer in the State of New Jersey introduced himself and discussed the application. The application is for a septic system alteration as a result of home inspection and sale of the property. The system is designed in the front yard and will utilize a pump. Everything else in the design is in accordance with the code. The new homeowners are aware of the deed restriction requirements.

The board asked Mr. Fine:

- 1. Drawing sheet 4 of 11 says it is a 1500-gal tank vs. the site plan on sheet 2 of 11 shows it is a 1300-gal tank
- 2. Soil log 3 in the rear of the yard. Why did you choose to build in the front?
- 3. On sheet 6 of 11 the design flow says 650 gal per day and should be 500 gal per day.

Mr. Fine responded:

- 1. Sheet 4 has been revised on 7/26/2024 after the HCHD caught that discrepancy. The system is a 1300-gal two compartment tank.
- 2. There wasn't enough room. There are the beginnings of a watercourse in the backyard. It is wetter back there and the slope falls off. It would be difficult to build back there and was decided it would not be a good area. There was machine refusal at 72 inches.
- 3. Yes, that should say 500 gal per day.

Chair Colburn asked if there were any additional questions or discussion; there was no response.

E. APPROVALS - EXPANSION/NEW CONSTRUCTION:

1. Block 96/Lot 22 – Mantz Engineering – 816 Route 22

Time heard 7:23 p.m.

James Mantz, a licensed engineer in the State of New Jersey introduced himself and discussed the application. His client purchased this property with an approved 3 bedroom dwelling septic system with a pump. The new owner decided to renovate it and make it a 4-bedroom dwelling. There is no change in the footprint and the soil testing has already been approved. The changes being made are to the size of the pump tank and the bed 21x50 instead of 21x40.

The board asked Mr. Mantz:

- 1. This is a new construction/expansion so you should have 8 weeks ground water monitoring and there should be soil logs for a reserve area according to regulation.
- 2. There is a typo in the size of the pump tank indicating it is 1500 gal when it should be 1300 gal

Mr. Mantz responded:

- 1. No, I don't. No records of the well were found.
- 2. The plan was reproduced as there were not many changes.

Chair Colburn stated Mr. Mantz will need 8 weeks of ground water monitoring and soil logs for a reserve area. Mr. Mantz thanked the board for their time.

H. NEW BUSINESS:

H.1 Rockaway Creek Testing

Susan Masinda, Readington Township resident and member of the Environmental Commission, presented her microbial source testing and findings to the board. Grant funded testing occurred. Initially HCHD required an address to investigate an issue. The DEP initially said they do not get involved in residential matters. Sewer lines were inspected, but no issues were found. It could be a sewer line from a neighboring municipality. A nearby farm reduced the number of grazing cows from approximately 175 to 20 cows and after 7 months resulted in no change leading to the idea it must be further upstream. Susan discussed the different streams and water courses current statuses. Different theories were discussed. DEP is now getting involved to investigate further. Ms. Masinda will report back.
