All applications must be received prior to **4:30 PM on June 14, 2024** via certified mail or overnight delivery. Hand deliveries are accepted as well at the Readington Township Administration Office, 509 Route 523, Whitehouse Station, NJ 08889.

To be eligible to apply, an applicant must:

- 1) Be eighteen (18) years of age or older;
- 2) Hold a valid New Jersey Division of Fish & Wildlife hunting license;
- 3) Maintain at \$1,000,000 in liability insurance;
- 4) Submit a \$100 non-refundable application fee in the form of a certified or cashier's check, payable to Readington Township; and
- 5) Submit a completed 2024-25 Readington Deer Management Application Package along with the consent to submit for background check form.

Detailed conditions and requirements for each application (which are not fully set out in this advertisement), as well as a copy of the proposed written agreement which the successful applicant shall sign, are available from the Readington Township Administration Office, 509 Route 523, Whitehouse Station, New Jersey 08889 or the Township website at www.readingtontwpnj.gov
