#### Readington Township Open Space Updates & Highlights - As of Feb. 15, 2025

First, a step back. Readington Township has a long history of being a pioneer with both Open Space and Farmland preservation. The township residents overwhelmingly approved the first municipal Open Space referendum in 1978. The first farm was preserved in 1987. Today there are approximately 74 farms preserved and a total of approximately 9,500 acres preserved, as Open Space or Farmland.

In 2018, Readington updated its Open Space Master Plan and committed to the preservation goal of 12,000 acres of preserved open space and farmland by 2050. This will require an additional 3,000 acres of land, either open space or farmland. This goal would preserve 40% of Readington lands with its success dependent upon the availability of Township, County, State and Non-Profit open space taxes and funding, as well as by opportunities provided by existing landowners willing to preserve their lands.

- 2018 Round Mountain 8 acres upland forest on summit of Round Mountain
- 2018 Cushetunk Mountain 3.8-acre steep slope woodlot adjoining preserved land.
- 2018 Cushetunk Nature Preserve 8-acre addition by South Branch of the Rockaway Creek
- 2019 Cushetunk Mountain 30-acre additions to Holland Brook Headwaters Natural Area
- 2019 Round Mountain 14-acre addition to Round Mountain section of County Park system
- 2019 Chambers Brook 35-acre open space preserve in the Chambers Brook headwaters area
- 2020 Chambers Brook 22.61-acre private open space in the Chambers Brook watershed
- 2020 South Branch of the Rockaway 1.5-acre open space in Whitehouse Station
- 2020 South Branch of the Raritan 56 acre preserved farm in Three Bridges Village greenbelt.
- 2020 South Branch of the Raritan 50-acre open space alongside State Wildlife Mgmt. Area
