E. Old Business
5. Facility Update-The softball fields held up great this summer. Lacrosse and Flag Football will be using Hillcrest Park, Holland Brook School fields and trying to avoid using Three Bridges fields. Rec \& Travel Soccer will be using Summer Road and Travel will use lights for practice week nights at Hillcrest Park. The Knights of Columbus would like to have bocce tournaments at Hillcrest Park, but the bocce court was not built correctly and they wanted to know if the Rec Committee would be willing to fix it. The Recreation Department received a quote for fixing the court at a cost $\$ 3,450.00$. The Knights of Columbus have offered to make a donation to help fix it. After some discussion it was decided to repair the court and promote it and advertise bocce clinics and try to build it up use with the assistance of the Knights of Columbus.
The Recreation committee requested that Gabrielle send a letter to baseball reminding them they would be charged full fee for 2017 facility use of Cornhuskers and Pickell fields and request a recommendation for portable mounds for Cornhuskers.
