# A RESOLUTION OF THE TOWNSHIP OF READINGTON IN THE COUNTY OF HUNTERDON, STATE OF NEW JERSEY AUTHORIZING MAYOR TO EXECUTE AN AGREEMENT WITH RARITAN TOWNSHIP MUNICIPAL UTILITIES RTMUA ("RTMUA")

- WHEREAS, pursuant to In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1 (2015) (Mount Laurel IV), on July 2, 2015, the Township of Readington (hereinafter "Township") filed a Declaratory Judgment Complaint in Superior Court, Law Division seeking, among other things, a judicial declaration that its Housing Element and Fair Share Plan (hereinafter "Fair Share Plan"), to be amended as necessary, satisfies its "fair share" of the regional need for low and moderate income housing pursuant to the "Mount Laurel doctrine;" and
- **WHEREAS**, the Township simultaneously sought, and ultimately secured, a protective order providing Readington Township immunity from all exclusionary zoning lawsuits while it pursues approval of its Fair Share Plan; and
- **WHEREAS**, that process ultimately led to the issuance of a Judgement of Compliance and Repose ("JOR"), which provided the Township immunity from builder's remedy litigation, and which approved the Township's Round 3 Housing Element and Fair Share Plan ("HEFSP"); and
- *WHEREAS*, and the Township's Round 3 HEFSP and JOR provided for a 100% affordable housing project to be located at Township-owned land, located at Block 81 and Lot 1, and referred to as the "Three Bridges 100% Project"; and
- **WHEREAS**, the approve plan contemplated that the Township would assist in securing sewer for the Three Bridges 100% Project by taking remedial issues to cure for sufficient I&I to developer the entirety of the 100% Project, which would be served by the RTMUA; and
- **WHEREAS**, the RTMUA owns and operates a wastewater treatment plant and wastewater system located in the Township of Raritan, County of Hunterdon, State of New Jersey; and
- **WHEREAS**, the RTMUA and Readington entered into a certain Agreement dated August 5, 1970 whereby Readington was allocated wastewater treatment capacity in the sewerage treatment plant owned and operated by the RTMUA in the amount of 100,000 gallons per day ("GPD") to service the southern portion of Readington known as the Three Bridges area ("Three Bridges"); and
- WHEREAS, on August 17, 1981 the RTMUA and Readington entered into an amended Service Agreement whereby Readington was allocated an additional 55,000 GPD of wastewater treatment capacity as a result of the expansion of the RTMUA's Wastewater Treatment Plant and Readington's need for additional capacity, thereby increasing Readington's total daily capacity allocation to 155,000 GPD; and
- WHEREAS, on March 23, 1995, the RTMUA and Readington entered into another amended Service Agreement (the "1995 Agreement") based upon the determination that Readington had a need for capacity in excess of 100,000 GPD but less than 155,000 GPD, and that 125,000 GPD was sufficient to address the needs and requirements of the Township of Readington, which Agreement superseded the agreements of August 5, 1970 and August 17, 1981; and
- *WHEREAS*, the parties desire to enter into a new Service Agreement which reflects their current needs and the circumstances surrounding the parties' relationship and to acknowledge sufficient capacity for the Three Bridges 100% Affordable Project; and

**SECTION 1.** The Township is hereby authorized to acquire from CHWSNJ001, LLC, the real property hereinbefore described as a portion of Lot 5.01 in Block 3.01 of the Official Tax Map of the Township of Readington, which property is more specifically described in the attached deed of dedication.

After all requirements respecting the enactment of this ordinance have been fulfilled the deed of dedication shall be recorded in the Office of the Hunterdon County Clerk.

**SECTION 2.** The Mayor and Township Clerk are hereby authorized to execute any and all instruments and to do all things necessary to effectuate the purposes hereof.

**SECTION 3.** All Ordinances, resolutions, and regulations or parts of ordinances, resolutions, and regulations inconsistent herewith are hereby repealed as to the extent of such inconsistency.

**SECTION 4.** If any section, paragraph, article, subdivision, clause, or provision of this Ordinance shall be judged invalid, such adjudication shall apply only to the section, paragraph, article, subdivision, clause, or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

**SECTION 5.** This Ordinance shall take effect upon final passage and approval in accordance with law.

# AUTHORIZING THE TOWNSHIP OF READINGTON TO ENTER INTO AN EMERGENCY CONTRACT WITH AURORA ENVIRONMENTAL FOR EMERGENCY FUEL LEAK MITIGATION AT DPW SITE

*WHEREAS*, on or about February 23, 2024, a diesel fuel leak occurred at the Department of Public Works Facility at 287 Mountain Road in the Township of Readington, and

**WHEREAS**, the Director of Public Works has determined that emergency repairs were required to remediate the damage before further contamination occurred; and

WHEREAS, there exists an immediate need within the Township of Readington for services related to emergency repairs related to this leak; and

**WHEREAS**, The Local Public Contracts Law, N.J.S.A. 41A:11-6, permits for any contract to be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefor, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services;

**WHEREAS**, the total contract amount has been quoted by Aurora Environmental at \$147,650 for: 1) removal of two (2) 4,000-gallon Con-Vault fuel tanks, 2) site remediation from fuel spill at DPW facility of up to fifty (50) tons, and 3) and \$6,000 in additional funds to be expended if the contamination on site exceeds fifty (50) tons;

**WHEREAS**, in no event should the amount to be paid pursuant to this resolution exceed of \$150,000 without amendment hereof;

WHEREAS, this procurement is further authorized pursuant to State Contract No. 42274;

*NOW, THEREFORE, BE IT RESOLVED* by the Township Committee of the Township of Readington, County of Hunterdon, State of New Jersey, as follows:

- 1. An award of contract for emergency repairs for the aforementioned diesel fuel leak is hereby made to Aurora Environmental, located at 1102 Union Avenue in Union Beach, NJ 07735 on an emergency basis, in an amount to be determined, but not to exceed \$150,000.00.
- 2. The Mayor, Adam Mueller, and the Township Clerk, Karin Parker, are hereby authorized to execute the township standard form of Contract for Goods and Services, or a contract as written to suit the emergency needs of the Township, as well as any non-substantive modifications thereto and related to such contract.
- 3. The Township Clerk is directed to forward a certified copy of this Resolution to the Qualified Purchasing Agent, Chief Financial Officer, Township Engineer, Township Attorney, and Aurora Environmental.
