Unfortunately, there was a separation of employment and since that time, an existing employee – who is a Certified Municipal Finance Officer – has assumed the title and the compensation is now paid via normal payroll. Additionally, the Township has employed a part-time finance assistant to help with the some of the tasks of the office due to the lack of a full-time CFO. Given the change of circumstances, there would be insufficient funds in the 2024 Salary & Wage line item for the Finance Office without the approval of the title and Text Resolution.
