2025 BUDGET DISCUSSION

• Public Works

Ron Christy, Director of Public Works, and Chris Szymanski, Public Works Supervisor were present to review the 2025 Department of Public Works Budget.

Mr. Christy discussed the individual line items for each of the divisions within the department, including Roads, Building and Grounds, Vehicle Maintenance, Parks Maintenance and Sewer Utility. He addressed an increase in the operating budget due to the large increases in the costs for materials, supplies, and vehicle parts. He highlighted the need to replace ageing vehicles and equipment and expand the workforce by four employees.

Mr. Christy spoke to the proposed capital requests for each of the divisions which include the following:

Building/Grounds - Cushetunk Dam Remediation, Three Bridges Library HVAC & Window Replacement, Historic Property Repairs, Replacement F-250 Truck, Salt Barn Repairs, Brine Application Unit and Double Wall Storage Tank

Park Maintenance – Ventrac Multi-Use Tractor and Repairs to the Pickell Park Pavillion

Road Equipment – 2 F-550 Trucks with Attachments, 2 F-250 Pickup Trucks with Plow and Street Sweeper

Vehicle Maintenance – Heavy Truck Lift, CNC Plasma Table and Service Vehicle

Sanitary Sewer – Skid Mounted Vacuum Pump

The Committee discussed the time required for maintenance of the recreation fields.
